1. Gift Aid allows charities to reclaim an extra 25p for every £1 you give, without any extra cost for you.
2. Don't use Gift Aid if you don't pay UK tax.
3. Gift Aid needs a full name and UK home address.
4. You must pay an amount of income tax and / or Capital Gains Tax for each tax year (6th April one year to 5th April the next) that is at least equal to the amount of tax that the charity will reclaim on your gifts for that tax year. If the charity or CASC gets back more tax than you've paid, HMRC may ask you to pay more tax to cover the difference.
5. If your circumstances change and you no longer pay enough Income and/or Capital Gains Tax to cover the amount claimed by MDSL Ltd, you can cancel your declaration by notifying MDSL Ltd. Your declaration will then not apply to donations you make on, or after the date of cancellation or such later date as you specify.
6. If you're a higher-rate taxpayer you can claim back the difference between the tax you've paid on the donation and what the charity got back when you fill in your Self Assessment tax return.
